Satish Goel asked the committee that a reasonable amount is already being being paid to the teaching staff of BCAIPGOCA and the salary of non-teaching staff may be increased keeping in view the workload and working hours of the non-teaching staff. After the eminent discussion and detailed deliberations, the members of the committee unanimously decided the increase in salary/honorarium as follows:
