	Preparation of Academic Calendar

1. Adherence to the Academic Calendar

The college adheres to the academic calendar provided by the affiliating Himachal Pradesh University for the conduct of Continuous Internal Evaluation system.

i. Preparation of Academic Calendar

A committee is constituted for the preparation of the academic calendar at the levels of the college and the Department in accordance with that of the affiliating university in consultation with IQAC.

Meticulous care is taken in the preparation of the calendar to include all the important details, to avoid unimportant information and to make the document accurate and precise. The calendar is distributed to the staff and students in time.

At beginning of the academic session, the principal convenes a meeting of the Staff Council to discuss the matters with respect to the formulation of academic calendar.

The preparation of academic calendar ensures that the students get adequate instructional hours and teachers get maximum hours to deliver their courses effectively. The academic calendar is prepared in tune with the conduct of examinations.

The classes for odd and even semesters commence in the month of July and December respectively in every academic year, whereas under the Annual system the classes commence from July. The tentative schedule and date of the commencement of classes for freshers, commencement of induction programme and Bridge Course for them and the dates of main events like annual athletic meet, intra-mural sports events, cultural events, annual function, etc. are included in the calendar.

ii. Academic Timeline

A timeline is suggested in the Academic Calendar to complete the syllabus and the schedule of the internal examinations is kept accordingly. In exceptional cases, the Council takes decision regarding the postponement or early conduct of examination. It happens rarely. Departments make teaching lesson plans for all the courses, detailing the extent of syllabus that will be completed at different time intervals, ensuring completion of at least 75% syllabus before internal examination.

Each department develops its academic timeline in alignment with the college academic calendar. It includes dates for other components of Continuous Internal Evaluation (CIE) viz. assignments, seminars, and projects. All the components of CIE, namely, assignments, seminars, test papers, projects and internships are conducted on time as per the academic calendar.

iii. Dissemination of Academic Calendar

To effectively integrate the continuous curriculum delivery with co-curricular activities, the college issues and uploads its own detailed academic calendar including schedule of internal

exams, assignment submission & evaluation, and other co-curricular activities on the website. This helps the students and teachers to plan the activities in an undisrupted manner.

iv. CIE System

The college strictly complies with the university guidelines for the conduct of CIE. As per the guidelines, CIE has a weightage of 30% of maximum marks in each subject. It includes 5% marks based on attendance record and 25% based on performance in the internal assessment. This weightage is communicated to the students right from the day of admission, specifically being the part of Prospectus and Orientation/ Induction Programme. Internal assessment rules are also uploaded on the website and repeatedly informed in the classes as well shared through website and WhatsApp group notifications.

Believing in continuous assessment, the internal assessment at the College comprises performance in the Internal Exams and in-Class Assessment. To ensure the effective conduct of CIE, the dates of Internal Exams are announced well-in advance by the Internal Examination Committee.

For in-Class Assessment, the teachers opt either assignment/project/class test/ presentation/ viva voce or any other mode of evaluation as per the need of the subject.

Students are given the opportunity to reappear and improve their performance in class tests / assignments to make learning a continuous process.

Students are bound to appear in these examinations/tests. Only those students who have a valid ground may be allowed to go for another examination for evaluation at a later date.

At the end of each session, the college issues admit cards to only those students who fulfil the minimum CIE criteria.

v. Impact of COVID-19 on Academic Calendar and CIE

Due to the Covid-19 Pandemic, the Academic Calendar for the 2019-20 and 2020-21 sessions were revised and extended. According to the affiliating University guidelines, the first- and second-year students were promoted to the next year, based on their internal assessment and previous year performance. However, for the final year students the written examinations were conducted following COVID SOPs keeping in view the student progression to different institutions of higher education spread over the country.

vi. Internal Examination as a component of CIE

As per the dates mentioned in the academic calendar internal examinations are organised by the Internal Examination Committee. The committee prepares the internal examination date sheet well in advance and intimates it to the students after approval of the principal through notices circulated in the classrooms and published on the college website.

The students are shown the answersheets by the teachers after the evaluation to maintain transparency in the process of CIE. Their performance is discussed with suggestions for improvement.

vii. Timely Uploading of CIE Awards on the University Portal

The Comprehensive Internal Evaluation awards of each course are uploaded by the concerned teacher with utmost care and verified by the internal examination committee on behalf of the principal. The university verifies and issues the admit cards only after the observation and completion of CIE process by the college.

viii. Grievances related to CIE Awards

The college appoints an incharge to deal with grievances related to CIE awards, errors, and omissions, if any, in respect of CIE awards as reflected in their grade cards.

Regarding Restricting the Entry of Officers/ Officials/ Teachers / Non-Teaching Staff of Educational Institutions/ District Office's in the Directorate.

In view of COVID-19, Pandemic as well as safety precautions and self regulation, instructions were circulated by this Directorate from time to time that visit / entry of Officers/Officials/ Teachers/ Non- Teaching staff working in the Educational Institutions & District Office's was restricted in the premises of this Directorate, unless he/ she has been permitted for the official work.
