2. The room tariff for staying in the above Circuit Houses and Rest Houses for more than five days continuously will be as under:-

1	Upto five days	Normal
2	For more than five days upto 15 days	Double the normal charges of that category
3	For more than fifteen days upto 30 days	Three times of the normal charges of that category
4	For more than 30 days	Four times of the normal charges of that category

3. The room tariff for staying in Circuit Houses and Rest Houses for the Officers/ Officials of State Government at the time of Transfer will be as under:-

1	For one week	Normal
2	For 30 days after one week	Double the normal charges of that category
3	For more than 30 days	Three times of the normal charges of that category

4. All the Circuit houses (except Circuit House Willy's Park and Peterhof, Shimla) will remain under the control of Deputy Commissioners concerned and rest houses will be under the control of Department concerned.

5. This issues with the prior concurrence of the Finance Department obtained vide their U.O. No. Fin.(C)B(15)-3/2020-55111511 dated 07-09-2020.

6. This will come into operation with immediate effect.
